1. Reviewed Minutes from 2/19/18 Meeting

Minutes were reviewed; corrections were made; Motion to accept corrected minutes was made, seconded, and passed (12 votes) 0 abstentions; 0 No's.

2. Moving Core to Provost Proposal:

R. Hessinger updated the Committee on the meeting he with N. Santilli; this issue is in a holding pattern until after N. Santilli meets with the new President and decisions are made there. S. McGinn voiced her opinion that moving the Core Committee would not solve any existing problems with the support of the Core (BSOB participation) and it would move the program to a more removed (and therefore less responsible) level of authority.

3. AW Proposal: EPA 232

Discussion amongst committee members on approving this class. R. Hessinger would like to hold off approving this until all committee suggestions are attended to on this course by the sponsoring faculty. He made the suggestion that he email the faculty to make sure all points are met and then he and T. Pace can approve this course. This was put to a vote:

Discussion then moved to the Course ESSS 435 that is up for review. T. Nlandu felt that since PL Department teaches ethics, that he should have been consulted on this class. Committee was in agreement and R. Hessinger will communicate with ESSS and the Dean's office.

5. Linked and TT Development Session before the April 5th Deadline?

R. Hessinger made the suggestions that a development session might want to be made before the April 5th deadline to the faculty to encourage more Linked and TT taught classes. He went on to say currently there are 14 linked classes scheduled for Fall of 2018. R. Hessinger mentioned he emailed the Chairs to say that these classes will first be capped at 20; once all linked pairs are up to 15; then the cap can be moved to 25. R. Hessinger also feels that with all the retirements coming this semester that JCU will be losing linked classes, and also that some faculty won't be available to teach Linked and TT classes as they will be covering other classes. A point was brought up that this is the time for Boler to get involved and offer these classes. R. Hessinger will coordinate a development session and send out an email with date and time.

6. Review of nominated Distribution Classes
