This is a summary of the annual report of the JOHN CARROLL UNIVERSITY BENEFIT PLAN, EIN 34-0714681, Plan No. 501, for period 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

JOHN CARROLL UNIVERSITY has committed itself to pay certain self-funded Medical claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with VISION SERVICE PLAN, CIGNA HEALTH AND LIFE INSURANCE COMPANY AND AFFILIATES, EYEMED VISION CARE ON BEHALF OF THE FIDELITY SECURITY LIFE INS. CO., FEDERAL INSURANCE COMPANY, and UNUM LIFE INSURANCE COMPANY OF AMERICA to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Business Travel Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$457,938.
