

# INTERNATIONAL APPLICANTS

In addition to completing the online academic program application, international applicants are required to send the supporting materials for the program of study and the materials listed below. Applicants should plan one full academic year in advance to ensure all necessary materials are received and processed on time.

## ADDITIONAL REQUIRED MATERIALS:

- Official transcripts from all colleges and universities previously attended. All transcripts from every college and university must be evaluated by WES or ECE and forwarded by the agency to the JCU Graduate School.
- Evaluation of English proficiency. Students whose native language is not English must demonstrate the necessary level proficiency in the English language by taking the Test of English as a Foreign Language (TOEFL) or the International English Language Testing System (IELTS). A student from abroad whose native language is English, who has completed their work at a foreign university where English is the language of instruction, or who has graduated from an American institution is exempt from this testing requirement, please contact us to have the requirement waived.
- Financial Guarantee Statement
- Current passport photo page, or copy of your current visa sticker.

**Depending on the academic program application, you will also be asked to provide the following supplemental materials:**

- Current Resume or CV
- Faculty Interview
- Letter(s) of Recommendation
- Statement of Purpose

**\*Please note:** Per government guidance, individuals seeking student visas are not eligible to enroll in 100% fully online degree programs, and depending on the visa type may only be eligible for one online or distance learning course each term. Further we are not authorized to offer online programs outside of the United States. Please check with the Graduate School if you have questions about these restrictions.

## COSTS & FINANCIAL ASSISTANCE

Please be aware that only a **very limited** number of scholarships for partial tuition or graduate assistantships are available and awarded on a competitive basis. Students who lack the means to cover tuition, travel, and living expenses are encouraged to explore external scholarships and loans.
